OFFICE MEMORANDUM

Sub: Filling up the post of Appraiser and Superintendent on deputation in Surat SEZ, Surat Sachin.

One (1) post of Appraiser and One (1) post of Superintendent are to be filled in by transfer on deputation in Surat SEZ, Surat ,Sachin. The pay Scale of Appraiser and Supdt. are Rs. 9300-34800 + 4800 (Group B Gazetted) . According to the recruitment rules, the post is to be filled in by officers working in the Customs/Central Excise Department holding the following qualifications:-

Deputation:

Officers of the Central Board of Excise & Customs:-

- (a) (i) holding analogous posts on regular basis in the parent cadre or Department ;
Or
- (ii) With three years service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 9300-34800 +4200 or equivalent in the parent cadre or department ; and
- (b) possessing two years experience in Central Excise or Customs procedural work.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding the appointment in the same or some other organization /department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application.)

- © The terms of deputation of Appraiser/Supdt. considered will be regulated in accordance with the instructions contained in Ministry of Finance O.M. No. 02/29/91/Estt(Pay II) dated 5-1-1994, as amended from time to time. On joining their new appointment, they will exercise option either to get their pay fixed in deputation post in accordance with the normal rules to draw pay of the post held by them in the parent department plus deputation allowance at the rate of 10% in accordance with and subject to the conditions laid down in Ministry of Personnel, Public Greivances & Pension, Department of Personnel & Training O.M. No. 2/8/1997-Estt (Pay II) dated 11-3-1998 & 2/22/B/Estt/Pay II dated 3-9-2008 as modified from time to time and such other general or special orders issued by the Ministry of Finance.
- (d) He will be entitled to transfer TA and joining time in accordance with the rules of the Government of India in force.

It is requested that the name of suitable officers may be recommended alongwith their upto date ACRs for last five years and Vigilance clearance for selection of the post of Appraiser/Supdt on deputation basis .Application without ACRs and Vigilance clearance certificates will not be entertained by this Administration. The last date for receipt of names is on 9-7-2009.
