**//OFFICE MEMORANDUM//**

**Sub: Inviting nomination for filling up a post of Superintendent of Customs (Preventive) in KASEZ & Surat SEZ, (Sachin), Surat.**

Two posts of Superintendent of Customs (Preventive) in the pay scale of Rs.6500-200-10500 in KASEZ & Surat SEZ, Sachin, Surat are to be filled in shortly. As such KASEZ Administration through the means of this office Memorandum invites nominations of suitable candidates for appointment as Superintendent of Customs (Preventive).

The method of recruitment and the field of the selection, as prescribed in the Recruitment Rules relevant to this post are reproduced below:-

**Transfer on deputation:-**

**1. Officers holding analogous posts in Commissioner of Customs and Central Excise;**

**or**

**2) Preventive Officers Examiners of the Customs, and Inspectors from Customs and Central Excise Commissionerate in the pay scale of Rs.5500-9000 with 3 years' regular service in the grade;**

**( period of deputation including period including period deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed 3 years).**

3. The selected officer will be treated as on deputation and his deputation terms will be regulated in accordance with the Ministry of Finance O.M.No.10(24) III (B)/ 60 dated 4<sup>th</sup> May, 1961 as amended from time to time. A list of duties and responsibilities attached to the post of Superintendent (P&I) are indicated in the enclosed annexure.

4. It is requested that this vacancy may be given wide publicity and the particulars of Officers who are willing to be considered for the appointment and also possess the requisite experience and whose services can be spared by the parent department may kindly be forwarded to the undersigned by 20/01/2006 alongwith upto date CR dossiers of the officer. Particulars of Officer(s) received after the closing date or not accompanied by the CR dossiers will not be considered.

5. During the course of selection the department eligible Preventive Officers will also be considered along with names forwarded by your Commissionerate.

6. The period of deputation of three years can be reduced at any stage be the KASEZ, Administration if deemed fit, without assigning any reasons thereof and the person appointed will be repatriated back to his parent department.

7. Officers who have given willingness for the post will not be permitted to withdraw his name at later stage in any circumstances which may please be noted.
